

## 2023/24 Governing board register of personal, pecuniary or business interests

All the governors and associate members of Wardley CE Primary School listed below have signed the **Register of personal, pecuniary or business interests**

This is a declaration of any personal or business interest they or any relative or person closely connected with them, have with businesses or other organisations that may have dealings with the school. This could for example include owning or having a relative work for a business that had dealings with school; having a relative working in or for school or being a governor of another school.

If any interest a governor has could be seen to cause a conflict of interest they would be asked to withdraw from any decision making concerned. This is to ensure that our governors can always be seen to be putting the interest of the school first.

If there is a potential conflict it is shown in the table. This table also shows the category of governor each person is, any specific role on the governing body and the committees they are members of.

### **The different categories of governors on our governing body are:**

- parent governors who have a child in school at the time of their election, and are elected by the parents with children at the school;
- staff governors who are members of staff at the school and are elected by their colleagues;
- foundation Governors are those appointed by the Church authorities;
- co-opted governors are appointed on to the governing body by the other members because they come from a specialist group, such as the business community or because they possess a particular skill which can contribute to the effective governance and success of the school;
- local authority(LA) governors who are nominated by the local councillor and appointed by the governing body;
- the Headteacher (HT) is also a member of the governing body by right of the position they hold in the school;
- associate members are not actually governors but can be appointed to serve on committees and attend meetings of the full governing body. They do not have the right to vote at meetings of the full governing body but may have been given voting rights on the committees that they are a member of, but these rights can only be given by the governing body.

### Explanatory notes:

The abbreviations used for the specific roles held by members of the governing board include the following:

COG = chair of governors; VC = vice chair of governors; SEND LG = special educational needs and disability link governor; SG LG = safeguarding link governor; H&S LG = health & safety link governor; GDPR LG = general data protection & regulation link governor; PSHE LG = personal, social & health education link governor. EYFS LG = early years link governor, RE LG = religious education link governor, CW LG = collective worship link governor; STEM LG = STEM subjects link governor (maths, science, computing & design technology); HUM LG = humanities subjects link governor (English, history, geography, modern foreign languages, music & art); PE LG = physical education link governor; ETHOS LG = ethos committee link governor. WB LG = whistleblowing link governor. ATT LG = attendance link governor.

### The different committees our governing body has are:

- School management sub-committee
- School effectiveness sub-committee
- Pupil welfare & community sub-committee
- There are also separate pay, disciplinary and appeals committees which are convened if they are required.
